

# Terms and Rules for the "European Championship Competition" ["EM-Wettbewerb"] from Sporttip

## **GENERAL PROVISIONS**

 "European Championship Competition" (hereinafter "Competition") is the name of a Swisslos Intercantonal Lottery prize draw in which players can take part in four electronic prize draws in the period from 6.06.2024 to 12.07.2024 without any obligation to purchase. In each draw, 25 betting credits of CHF 100 each with a total value of CHF 2,500 will be raffled off. The betting credits must be activated and redeemed by 31.08.2024.

#### **ENTITLEMENT TO ENTER**

- 2. Any natural persons over the age of 18 who are resident in the Swisslos territory (cantons AI, AG, AR, BE, BL, BS, GL, GR, LU, NW, OW, SG, SH, SO, SZ, TI, TG, UR, ZG, ZH and the Principality of Liechtenstein) are entitled to enter.
- 3. Each person may only enter the competition once.
- 4. Employees of Swisslos, employees of the agencies or partner companies tasked with carrying out the competition, and any family members of these employees who live in the same household are excluded from entering the competition.
- 5. Entries with temporary or fake e-mail addresses created using scripts, automated entry services or similar methods are strictly prohibited subject to legal measures.

#### **ENTRY**

- 6. To enter the competition, the participant must have answered the competition question. In addition, the e-mail address provided must be confirmed.
- 7. In accordance with point 6, every entry automatically leads to participation in the competition prize draw. Anyone who is drawn in a draw is excluded from further draws.

### **MECHANISM**

8. You can only take part in the prize draw online. In order to take part in the prize draw registration on the landing page with first name, surname, e-mail address and zip code is required. The conditions of participation must be accepted.



#### **COMPETITION PRIZES**

9. The following prizes can be won:

- 10. a maximum of CHF 100 in betting credit will be awarded per person.
- 11. the prizes will be drawn at random from all eligible participants. The winners will be notified by e-mail within two (2) working days of the above-mentioned draw dates.
- 12. Swisslos is responsible for running the competition. All decisions concerning the conduct of the prize draw will be taken in consultation between the Swisslos representatives present. Decisions and the results of the draw are final.

#### **MISCELLANEOUS**

- 13. Participants who violate and/or manipulate the Terms and Rules can be excluded from the competition. If there are grounds for exclusion, corrections may be made to the rankings and any prizes may be withdrawn (even at a later time), or any prizes paid or sent out can be reclaimed.
- 14. Swisslos as organizer or the agencies or partners tasked with carrying out the competition are entitled to suspend, cancel or stop the competition if it can no longer be duly carried out, especially in the case of hardware or software failures, program errors, computer viruses or unauthorized access by third parties, as well as mechanical, technical or legal problems.
- 15. Swisslos will endeavour to make the competition playable on all common web browsers and the latest versions of these browsers. Entitlement to play cannot be inferred if a web browser or a version of it is not supported.
- 16. If e-mails cannot be sent to winners (due to technical problems, for example), there is no entitlement to compensation.
- 17. By entering this competition, the participant accepts these Terms and Rules as well as any publicity associated with a win, in particular that their name and place of residence may appear and/or be published on both the Swisslos website (www.swisslos.ch) and in other media.



In the event that details are accidentally published incorrectly, only the draw results are binding for the entitlement to a prize, and not the incorrect details published.

Furthermore, the participant agrees to receive information from Swisslos about other lottery and betting products. Data is never passed on to third parties. This consent may be revoked at any time by deregistering.

- 18. No correspondence will be entered into with regard to the competition. The judges' decision is final.
- 19. The present Terms and Rules supplement the Terms and Rules for participation via the Internet Gaming Platform issued by Swisslos Interkantonale Landeslotterie.
- 20. Where the English, French or Italian version of these Terms and Rules deviates from the German version, the German version alone is binding.
- 21. These conditions of participation are valid from 05.06.2024
